Object: informative note on the processing of your personal data in compliance with art. 13 of Legislative Decree 196/2003 providing the code in relation to the protection of personal data, and requests your consent to effectuate such processing.

We wish to inform you that for the conclusion and the execution of contractual relationships in progress with you, our organization is in possession of your personal data, including those acquired verbally, directly or from third parties, data defined as personal by Legislative Decree 196/2003 - Personal Data Protection Code. This code provides that whoever processes personal data is required to inform the person in question on which data will be processed and some qualifying elements of the processing; this should happen lawfully and openly, safeguarding your privacy and your rights.

In compliance with this regulation we wish to provide you with the following information:

## Nature of Data Processed

We process your personal and fiscal information, as well as data of economic nature which are necessary for the execution of contractual obligations with you, now or in future. The data which you submit to us and which we collect (such as photo, video, processed through physical or digital methods etc.) will be handled by us in compliance with the relevant laws in place. ## Purpose of processing

Subjects that can access the data with a legal order, regulations and legislation, within the framework of the legal provisions in place.

Subjects who need to access your data for the purpose of assisting the relationship which exists between you and us, within the strict limits required to fulfil their duties (such as shipping or credit agencies)

Subjects who we consult, for the purpose of fulfilling their duties for our organization, and who are subject to a letter which demands privacy and discretion.

It is also our intention to publish on the website the relevant information regarding our business agreement and relationship with you.

## Your rights

Below is an extract of art. 7 of Legislative Decree 196/2003, to remind you that you may address and exercise the following rights with us:

obtain the confirmation of the existence or not of personal data relating to you, even if they are not yet registered, and have their communication in an intelligible form

obtain information on the source of the personal data, as well as their purpose and how they will be processed

obtain information on the strategies applied when processing is carried out by electronic means

obtain the update, the correction or where interested, the integration of data

obtain the deletion, the transformation into anonymous format if interested, or the blockage of data whose storage is not necessary for the purposes for which the data were collected or subsequently processed.

obtain certification that the actions in points a) and b) are notified, also regarding their contents, to those to whom the data have been disclosed or disseminated, except in cases where such a fulfilment is deemed impossible or involves means which are manifestly disproportionate in relation to the protection of the rights.

object, in whole or in part to, for legitimate reasons, the processing of personal data relating to you, even if pertinent to the purpose of collection

object, in whole or in part, to the processing of personal data relating to you for the purpose of sending advertising material, direct marketing, or for conducting market research or business related communication.
